1. Introduction

The Task 1.1 includes the identification and involvement of stakeholders for capacity building in Environmental risk assessment and mitigation for International, National and Regional Cultural Heritage assets. Following a multi-level approach, a variety of local, national, and international stakeholders have been identified within technical, scientific, organizational, institutional, human, educational areas. The involvement of Associate Partners such as UNESCO Office in Tashkent and Ministry of Culture of the Republic of Uzbekistan in future steps will ensure a correct comprehension of the real needs.

2. List of Main stakeholders of Uzbekistan for Cultural Heritage Conservation and Management

Three institutions roughly can divide the stakeholders for cultural heritage conservations of Uzbekistan. There are local authorities and institutions, educational institutions and international authorities.

The main authority responsible for the management of the cultural heritage properties is the "Principal Department for Preservation and Utilization of Cultural heritages" of the Ministry of Culture of the Republic of Uzbekistan (Board of Monuments). In briefly, this government organization is known as "Board of Monuments".

The Board of Monuments is the Focal Point for all cultural heritage properties of Uzbekistan. Uzbekistan counts with four UNESCO World Heritage Properties, with hundreds of historic monuments and traditional historic houses. These world heritage sites are located in Samarkand, Bukhara, Karshi and Khorezm cities. The Board of Monuments has its branch offices in each provinces of Uzbekistan. Well-known branches are Samarkand, Bukhara, Khorezm and Karshi Regional State Inspection on Preservation and Utilization of Historical and Cultural Properties.

Board of Monuments and its Branch offices as a State Inspection works closely as a partner with following stakeholders (Table 1 and 2).

3. List of Main stakeholders of Tajikistan for Cultural Heritage Conservation and Management

Tajikistan has a two UNESCO World Heritage Properties and sixteen heritages are in UNESCO tentative list. More over in Tajikistan exists more than two thousand historical heritages.

Same as Uzbekistan, the main authority responsible for the management of the cultural heritage properties is Department for the Protection and Use of Historical and Cultural Heritage Ministry of Culture of the Republic of Tajikistan. This department is responsible for implementation of the State Program for protection and use of historical and cultural heritages of Tajikistan. The department has its branches in each provinces of Tajikistan and they are called local inspections.

Management and conservation principles are almost same with Uzbekistan. Main stakeholders for conservation and management of cultural heritages of Tajikistan are given in Table 3 and 4.
